1) PROVISIONAL MEETINGS

STANDARD COURSE: Attendance at SEVEN MEETINGS

Alternate dates are based on assignment to a Tuesday Night or Wednesday Night Provisional Group. The maximum number of absences allowed is Two. The Second Absence requires a make-up. All make-up meetings will need to be submitted in writing and approved in advance to the Group Leaders. Approved make-up meetings are the following and are limited to the meetings listed below: 1 extra Volunteer Training & Leadership Meeting; 1 extra Done-in-a-Day Event; 1 extra Fundraising Event; 1 extra Peg's Closet shift. After the Third absence or if the Make-up meeting for the Second absence is not completed by May 12, 2010, the Provisional will be automatically deferred to a future course.

ACCELERATED COURSE: Attendance is required at all FOUR MEETINGS

Alternate dates are based on assignment to a Tuesday Night or Wednesday Night Provisional Group. Because of the focused curriculum, ALL meetings must be attended to graduate from this course. If you are unable to attend all four training meetings and satisfy the additional requirements (see below) you cannot be voted to active status and/or placed on an active NYJL committee.

2) VOLUNTEER ACTIVITIES- Attend each of the FIVE following activities by May 12, 2010:

1. 1 Volunteer Training & Leadership (VTL) Meeting
2. 1 Playground Improvement Project [PIP] Day (the date will be decided by your Group Leaders)
3. 1 Community Activity (a Done In a Day [DIAD] Event OR an Evening at Peg's Closet, the Pelham Fritz Clothing Bank) OR 1 Fundraising Event (Winter Ball Set up OR House Tour)
4. 1 Community Walking Tour (the Walking Tour and date will be decided by your Group Leaders)
5. Attend Placement Previews, April 29, 2010

3) FINANCIAL OBLIGATIONS- The Provisional will need to be current in all of her NYJL financial obligations, including Dues and House Account Charges, in order to enroll in and graduate from the course.

1. If the account is not current, the Provisional cannot be moved to Active Status by the Board of Directors and cannot be placed on a committee following the end of the Provisional Course.
2. The Spring 2010 Provisional fees are as follow: \$100.00 Application fee; \$150 Provisional Training Course Fee and \$260 NYJL Dues, totaling \$510.00. Please note: the Application fee is non-refundable. The Provisional Training Course Fee is 100% refundable if one cancels her participation before Meeting 1. In addition, the course fee is transferable if one defers her participation up to two times. After Meeting 1 but before Meeting 2, the course fee is 50% refundable if a written request is made to the Volunteer Development Council Head. No refunds will be issued after Meeting 2 or after two course deferments.

*Dates and locations of meetings are subject to change.

I have read and understand the above requirements for the Spring 2010 Provisional Course. I understand it is my responsibility to complete the above requirements. If I am unable to complete this Course, I will be deferred and have the option to repeat the Provisional Course in its entirety, at my own expense. I understand that no fees can be refunded.
