The training course focuses on board roles and responsibilities, monitoring fiscal policies, understanding legal responsibilities and development strategic plans and fund development support. In Fiscal Year 2015, 124 people participated in the course and 90 non-profit agencies provided placements and networking opportunities. The Forum for Non-Profits is an annual half-day education conference open to New York Junior League volunteers and the general public. Attendees address key issues facing both nonprofits and the communities they serve.
